Award:

Two (2) \$1,000 scholarships will be awarded to two (2) deserving graduating High School Seniors for their accredited educational institution. (\$1,000 will be awarded to each winner.)

Eligibility:

- Applicant must be a primary member (not just a joint member on someone else's account) of Hudson River Teachers Federal Credit Union. If you are not a member, please visit our website at www.hudsonriverteachers.org to download an application for membership.*
- Applicant must be a graduating high school senior.*
- Applicant must be accepted as a full-time student at an accredited (2) or (4) year college or university.*
- Applicant cannot be related to a Hudson River Teachers FCU employee, Board member or Supervisory Committee member.*

Selection Process:

Judging will be based upon subjective criteria including academic achievement, extra-curricular activities, community service, written essay and personal goals.

Applicant will not be considered unless all information is completed and requested documentation is provided.
Application must be postmarked no later than Friday, May 7, 2010.
